## SOCIAL SECURITY NUMBERS

Social Security information will only be used in the event you hire the Attorney to represent you in your legal matter and then only when necessary in limited use during the course of your matter.

## FURTHER REPRESENTATION AFTER YOUR INITIAL CONSULTATION

Following your initial consultation, if you agree to hire the Attorney for further services and the Attorney agrees to represent you, you will both sign a written Legal Services (Retainer) Agreement. The Legal Services Agreement will set forth the terms and conditions of representation, including fees. Estate planning services and business formation services are generally flat fees. In ordinary probates, fees are set by statute. Contingency fee arrangements may be available on selected matters. Most legal services are billed on an hourly rate, Attorney's current rate is \$425 per hour. Your Legal Services Agreement will set forth the specific fee arrangements for your matter.

If your legal problems involve a potential lawsuit, it is important that you realize a lawsuit must be filed within a certain period of time called a Statute of Limitations. If the Attorney is not hired to provide further services, you are strongly urged you to immediately consult with another attorney to protect your rights. If the Attorney does not agree to represent you, the Attorney's decision not to represent you should not be taken by you as an expression regarding the merits of your case.
